Disclosure on Liquidity Risk as on 31st March 2023

RBI has issued guidelines on Liquidity Risk Management Framework for Non-Banking Financial Companies including Housing Finance Companies. As per the guidelines, the disclosure on liquidity risk as at March 31, 2023 is as under:
